SJI can accept no responsibility for losses or additional expenses due to delay or changes in air or other services - due to sickness, weather, strike, war, quarantine or other causes or acts of God. Although SJI anticipates no changes in the itineraries or accommodations, etc., the right is reserved to make any changes with or without notice that might become necessary in the best interest of the tour including the substitution of hotels booked if this becomes necessary.
